

STORAGE AND DISPOSAL

Store in the closed, original container in a cool, well ventilated area and away from children, animals, food, feedstuffs, seeds and fertilisers. DO NOT store for prolonged periods in direct sunlight. Triple rinse containers before disposal. Add rinsings to spray tank. DO NOT dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush or puncture and deliver empty packaging to an approved waste management facility. If an approved waste management facility is not available, bury the empty packaging

500mm below the surface in a disposal pit specifically marked and set up for this over normal clothing, buttoned to the purpose, clear of waterways, desirable vegetation and tree roots, in compliance elbow length PVC gloves.
