

STORAGE AND DISPOSAL

Store in the closed, original container in a dry, well-ventilated area. DO NOT store for prolonged periods in direct sunlight. The method of disposal of the container depends on the container type.

For Non-Refillable Containers: Store in the closed, original container in a dry, well-ventilated area. DO NOT store for prolonged periods in direct sunlight.

Triple or preferably pressure rinse containers before disposal. Add rinsings to spray tank. DO NOT dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or a designated collection point. If not recycling, break, crush or puncture and bury empty containers in a local authority landfill. If no landfill is available, bury the containers below 500 mm in a disposal pit specifically marked and set up for this purpose, clear of waterways, desirable vegetation and tree roots.

Empty containers and product should not be burnt.

For Refillable Containers: Storage must be secure so that contents cannot be tampered with. All locks and/or seals must be in order. If locks or seals are broken prior to initial use then the integrity of this product cannot be assured. If this occurs Apparent Pty Ltd should be advised immediately. Empty contents fully into application equipment. Close all valves and return to point of supply for refill or storage.

SAFETY DIRECTIONS

Very dangerous. Poisonous if absorbed by skin contact, inhaled or swallowed. Will irritate the eyes, nose, throat and skin. Avoid contact

with eyes and skin. DO NOT inhale spray mist. When preparing spray and using the prepared spray, wear cotton overalls buttoned to the neck and wrist, washable hat, elbow-length PVC gloves and face shield or goggles and half-face respirator or disposable respirator. If clothing becomes contaminated with product or wet with spray remove clothing immediately. If product on skin, immediately wash area with soap and water. After use and before eating, drinking or smoking, wash hands, arms and face thoroughly with soap and water. After each day's use, wash gloves, face shield or goggles, respirator and if rubber wash with detergent and warm water, face shield and contaminated clothing.

FIRST AID

If in eyes, hold eyes open, flood with water for at least 15 minutes and see a doctor.

Additional information required under the Globally Harmonised System (GHS) classification of the substance/mixture:

Keep only in original container. May cause an allergic skin reaction. Fatal if inhaled. May cause respiratory irritation. Causes damage to organs through prolonged or repeated exposure. Very toxic to aquatic life with long lasting effects.

May be corrosive to metals. Use only outdoors or in a well-ventilated area. Contaminated work clothing should not be allowed out of the workplace. Avoid release to the environment. IF SWALLOWED: Call a POISON CENTER or doctor/physician if feel unwell. IF INHALED: Remove victim to fresh air and keep at rest in a position comfortable for breathing. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Immediately call a POISON CENTER or doctor/physician. Store in corrosive resistant container with a resistant inner liner.
