Directions For Use:

SITUATION	USE RATE	CRITICAL COMMENTS
Agricultural Spray Tanks	20 mL/1000 L	Use rate will vary dependent upon amount of foam present. Where large quantities are forming better control may be achieved by predilution Let's Go Anti-Foam 1:5 in water before addition to tank.
High Agitation Conditions	1000 mL/1000 L	Add Let's Go Anti-Foam before foam levels are high.
Dip Tanks for Fruit	20 mL/1000 L	Vary usage as required.

#### General instructions:

Let's Go Anti-Foam is a special purpose foam suppressant for use in agricultural chemical sprayers and also for use in dip tanks commonly used in the grading of pome and stone fruit. In situations where agricultural formulations and surfactants are under agitation during tank filling large amounts of foam can form. Let's Go Anti-Foam should be added to the tank before foam levels build to excess so that filling can continue.

#### MIXING INSTRUCTIONS:

Shake container before use. Let's Go Anti-Foam can be prediluted 1:5 in water or added directly to the spray tank.

#### PROTECTIONS OF WILDLIFE, FISH CRUSTACEANS AND ENVIRONMENT:

Do not contaminate streams, rivers or waterways with chemical or used containers.

#### STORAGE AND DISPOSAL:

KEEP OUT OF REACH OF CHILDREN. Store in closed, original container in a well ventilated area, as cool as possible. Triple or, preferably pressure rinse containers before disposal.

#### SAFETY DIRECTIONS:

Do not swallow. Avoid contact with skin or eyes. Wear rubber gloves, overalls and goggles or face shield. Wash hands with soap and water after use.

#### FIRST AID:

If poisoning occurs, contact a doctor or Poison Information Centre (Phone Australia 131126). If in eyes, hold eyes open and flood with water for at least 15 minutes and see a doctor.
