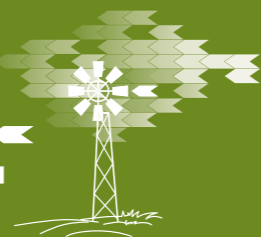

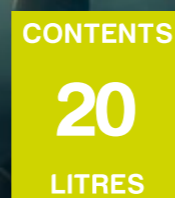
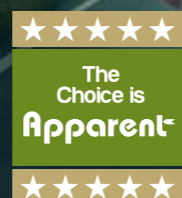

HERBICIDE

ACTIVE CONSTITUENT: 525g/L NONANOIC ACID

For non-selective control of seedling and young broadleaf and grass weeds, for suppression of established weeds and perennial species and for control of Moss and Algae according to the directions for use.

Apparent Alternative Herbicide

STORAGE AND DISPOSAL:

Store in the closed, original container in a cool, well-ventilated area. Do not store for prolonged periods in direct sunlight. Triple-rinse containers before disposal. Add rinsings to spray tank. Do not dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush, or puncture and deliver empty packaging to an approved waste management facility.

If an approved waste management facility is not available, bury the empty packaging 500 mm below the surface in a disposal pit specifically marked and set up for this purpose, clear of waterways, desirable vegetation and tree roots, in compliance with relevant local, state or territory government regulations. Do not burn empty containers or product.

Refillable Containers: Empty contents fully into application equipment. Close all valves and return to the point of supply for refill or storage.

SAFETY DIRECTIONS

Will irritate the eyes and skin. Repeated exposure may cause allergic disorders. Avoid contact with the eyes and skin. When opening the container and preparing spray wear cotton overalls buttoned to the neck and wrist (or equivalent

clothing), elbow-length chemical resistant gloves and face shield or goggles. When using the prepared spray wear gauntlet-length chemical resistant gloves and face shield or goggles. Wash hands after use. After each day's use wash gloves, face shield or goggles, and contaminated clothing.

FIRST AID

If skin contact occurs, remove contaminated clothing and wash skin thoroughly. If in eyes, hold eyes open, flood with water for at least 15 minutes and see a doctor.
